There was further evidence from a Kitiumgar Indian; from James Haman, a special constable; a Chief named Lagatta; and a teacher at the mission house, Charles Ridley.

There was also details of an inquest on the death of Tobusk who had been shot by Chief Molahan. Evidence was given by Phillip Wilson; an Indian from Kitzegueta named John; and Low-kia-tem-sam-in-luck. They found that Chief Molahan was justified in shooting Tobusk.

Jim apparently panicked when he saw the white constables and their fire arms. Powell states "It would appear that a great blunder has been perpetrated by the constable in shooting the Indian..."

They also anxiously wish me to go... " He pleads bad health but says he will go if the Department desires. He encloses clipping from Daily Colonist. See Card 73. Tells of Todd's visit to Upper Skeena in April. Todd confered with wanted Indians friends and told them "he would see that the Indian had a fair trial" and advised that "his best course was to return and surrender". "Further, he wrote a letter to the same effect to the Indian..." Powell believes the Indian (Jim) had come in to surrender when he was shot by the constable. He notes that the Indians are the ones "among whom the Rev. Mr. Tomlinson has resided and for a long time have assumed a hostile and defiant attitude towards the Government in respect of their claim to the whole country and last year refused to permit Mr. O'Reilly to set aside reserves for them." Note: Powell states at this time with regard to the B.C. Govts. request for him to go to Skeena "It appears to me, also important that I should go ..." Then he gives reasons whyhe should!

Question - How much had this letter to do with the future action of the B.C. Govt.?

Just over 2 columns. Talks of the material advance of the Indians. They never come into contact "with the better class of whites". One tribe on the Nass went so far last year as to request the Government to order the removal of a white man holding a patent from the Crown for the land upon which he is settled....The Tsimpsean, Naas, and Skeena Indians....have...demanded that the entire province be regarded as the property of the Indian tribes..." Quotes from a "demand" of the Nass Indian Chiefs.

That the constables five in number and Hudsons Bay Servants are beleaguered at Hazelton by Indians who demand a life in place of deceased and money compensation that lives of all Whites at the place in great danger and reinforcements are asked without delay. It is deemed advisable for their prompt relief that permanent corps active militia Stationed herebe directed to proceed hazelton forthwith that course would also have effect of effectually establishing order in that hitherto turbulent and disaffected locality and I request that requisite instructions be given for the expedition." Punctuation supplied.
